# 595.6 Conditions of Use

- .1 Each development shall be consolidated into one Lot.
- .2 A Golf Course or Golf Driving Range shall only be permitted:
  - a. where lights are not mounted so as to direct a glare onto any residential Use or any street; and
  - b. where a fence for the control of stray golf balls is located within 12.0 m from any Lot line, is kept in good repair and is bordered with a landscaped area.
