### 610.5 Landscaping and Off-Street Parking

#### 610.6 Conditions of Use

- .1 Notwithstanding section 140, a Home Occupation Level 3 shall: (B/L 3249-2022)
  - a. not exceed a floor area of 185 m<sup>2</sup> per Lot; and
  - b. not exceed four employees, including any Resident.
- .2 Notwithstanding section 140, two Home Occupations shall be permitted on the same Lot, provided that only one is a Home Occupation Level 3. (B/L 3249-2022)
- .3 Unenclosed storage shall be permitted subject to the following regulations:
  - a. not be located within 3.0 m of an Exterior Lot Line;
  - b. be bounded on all sides not adjacent to a Building or Structure by a solid fence or wall of at least 1.8 m in Height;
  - c. be limited to that part of a Lot that is surfaced with asphalt paving, concrete or another dust free material; and
  - d. not include storage of materials or goods likely to produce or give off dust or other particulate matter that may become wind-borne.
