## 862.5 Off-Street Parking

- .1 Notwithstanding Section 150, the minimum number of off-street Parking Spaces within the N62 zone shall be two spaces contained within a garage per Dwelling Unit.
- .2 Notwithstanding Section 150, a tandem garage is not permitted.

#### 862.6 Subdivision Regulations

- .1 A Rowhouse may be developed so that either:
  - a. each group of Dwelling Units in a Rowhouse is located on one Lot; or
  - b. each individual Dwelling Unit in a Rowhouse is located on its own separate Lot.
- .2 Where each individual Dwelling Unit in a Rowhouse is located on its own separate Lot, all newly created Lots for a Rowhouse shall be a minimum lot size of 190 m<sup>2</sup>.
